To: All Poultry Hatchers in Assam

Subject: Advisory on ban on cruel and illegal methods for killing of unwanted chicks by poultry hatcheries in Assam and the implementation of method prescribed by the AWBI and other bodies.

Sir,

It has been brought to the notice that millions of male chicks (since they can't lay eggs) and chicks who are deformed, sick, or "low grade" are considered useless by the poultry industries and killed via various illegal and cruel methods, which include drowning, burning, crushing, grinding, or suffocating them or even transporting them to be eaten alive at fish farms. Some chicks who have been dyed with chemicals and distributed or sold in villages to children also typically die soon from the paint, neglect, or other reasons.

It should be noted that such illegal and cruel methods of killing unwanted chicks violate Section 11 of the Prevention of Cruelty to Animals Act, 1960 (PCA Act), and are punishable under this Act. (A copy of Section 11 of the PCA Act is appended as Annexure 1.)

You are, therefore, directed to:

1. Stop immediately all illegal and cruel methods of killing of male/unwanted chicks in your hatchery/hatcheries and
2. Practice use of nitrogen and inert gas method of controlled atmospheric killing to euthanize male/unwanted chicks because they cause the least amount of pain and result in less overall suffering.
(A copy of the AWBI Advisory is appended as Annexure 2 and Article 7.6.14 of the OIE guidelines as recommended by the AWBI and the LCI is appended as Annexure 3)
3. Prohibit the practice of killing day-old male chicks and adopt ~~in~~ ovo sex-determination technology once it's commercially available.
