ORDERS BY THE GOVERNOR OF ASSAM Notification

Whereas, the State of Jharkhand has contained the Avian Influenza to a large extent and thereby reduced the possibility of spread of the disease to neighbouring States, namely, West Bengal and other North Eastern States including Assam,

In view of the above, the Governor of Assam is pleased to allow transportation of poultry through Assam to other North-Eastern States with immediate effect until further order subject to observance of SOP dated 02/06/2023.

The ban imposed earlier on the transportation of poultry to Assam will continue ,however, one-day-old chicks are allowed for transportation through rail, road, and air to Assam for use by farmers in the State as there is the absence of breeding farms in the State subject to observance of SOP dated 02/06/2023.

Further, active and targeted surveillance against the disease in terms of the guidelines issued by the Government of India will continue at the inter-state borders so as to prevent entry of infectious poultry to the North Eastern states through Assam.
