

Separate sealed tender in prescribed format affixing non-refundable court fee stamp of Rs.8.25 (Rupees eight and paise twenty five) only for a validity period of 180 (one hundred eighty) days are hereby invited from the eligible contractors duly registered under Animal Husbandry & Veterinary Deptt. Assam, Guwahati-3 and Dairy Development Deptt. of Assam, Khanapara, Guwahati-22 for the following works under **SOPD-G (Major)** as shown in the table below and will be received by the undersigned on or before **26.10.2022** hours of **14.00** and will be opened on the same day at 14-30 hours in presence of tenderers or their authorized representative who wish to attend the same.

If the date of the opening of tender happens to be a holiday / bandh or if it is not possible to receive tenders in stipulated date for any unforeseen reason, the next working day will be considered as the last date for receipt / opening of the tenders
