The Office of the Director, Animal Husbandry and Veterinary Directorate now invites sealed Quotations from reputed & eligible bidders for supplying 300 (Three Hundred) Cow Mats at Gorukhuti Multipurpose Agriculture Project (GMAP), Sipajhar, Darrang, Assam.
- 2. The RFQ Document is attached to this Procurement notice and it includes documents to facilitate preparation and submission of quotations, criteria for qualification, evaluation procedure, award of contract and relevant forms to be filled by bidders. - 4. The Quotations will be opened on the same day, i.e., **28**th **January**, **2022** at **14.30 hours** in presence of the bidders or their representatives who choose to attend at the office of the undersigned.

- 2. **Eligibility:** A Bidder (a) shall not participate in more than one Quotation; (b) shall not have conflict of interest as defined in the Bank's Procurement Regulations; and (c) should not have been (i) temporarily suspended or debarred by the World Bank Group in compliance with the Bank's Anti-Corruption Guidelines and its Sanctions Framework; or (ii) blacklisted or suspended by Central or any State Government Departments in India.

- 5. Preparation and Submission of Quotation:

  - b) Quotations shall be submitted as per the format given at Annex- I along with other supporting documents as mentioned in the bid with a copy of the RFQ placed in a single sealed envelope, clearly marked as "Quotation for supply of Cow Mats; Not to be opened before 28th January 2022 at14.30 hours"." The name of the bidder, address and contact no. should be mentioned on the reverse of the sealed envelope.
  - c) All pages of the quotation shall be signed and stamped by the authorized person to indicate that the bidder has agreed to all terms and conditions of the quotation. Overwriting, alterations, if any, in the quotation should be signed by the authorized signatory.
  - d) Quotation not accompanied by specified documents, self-declarations, signatures may be rejected by the office as non-responsive and may not be evaluated.
  - e) All duties, taxes and other levies payable by the bidder under the contract shall be shown separately.

- 7. **Conformity:** Bidder shall furnish as part of the Quotation, documentary evidence to substantiate that the Cow Mats to be supplied conform to the laid down technical specifications & standards, as relevant e.g. brochure, catalogue, warranty/ guarantee etc. of the manufacturer.

#### 8. Quotation Prices

- a) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment/modification on any account. A Bid submitted with an adjustable price quotation will be treated as non-responsive and rejected.
- b) Corrections of the quoted rate, if any, shall be made by crossing out, re-writing, initialing and dating.
- c) 'Discount' or extra charges if any mentioned by the bidders shall not be considered unless these are specifically indicated in the price schedule.
- d) All duties, taxes and other levies payable under the contract shall be shown separately.
- e) The Prices should be quoted in Indian Rupees only.
- 9. **Right to Vary Quantities**: Director, Animal Husbandry & Veterinary reserves the right at the time of award of contract to increase or decrease the quantity of service specified in the schedule of requirements without any change in price of the offered quantity keeping the other terms & conditions intact.
- 10. **Validity of Quotation:** Quotation shall remain valid for a period not less than 30 days after the deadline date specified for submission.
- 11. **Signing of Quotations**: The name and position held by each person signing the quotation and related documents must be typed or printed below the signature.
- 12. **Quotation Submission**: Bidders may submit their sealed envelopes containing the bids by post or by hand or drop in the box earmarked by the Employer. The copies of all the supporting documents shall be signed/self attested by the Bidder.
- 13. **Literature:** Wherever applicable, literature like catalogs, instructions, operating manuals, etc. shall be enclosed with the Quotation. The documents should be in English language.
- 14. **Warranty & Maintenance:** The Cow Mats supplied shall be under warranty at least for one (1) year and thereafter shall be under Annual Maintenance Contract (AMC) for three (3) years.

#### 15. Evaluation of Ouotations:

- a) The Office of the Director, Animal Husbandry and Veterinary Department shall evaluate and compare the quotations determined to be substantially responsive, i.e. which,
  - i. are properly signed and sealed;
  - ii. have submitted the required documents and meet the criteria specified as indicated above;
- b) Evaluation shall be carried out on the basis of the total price quoted for.
- c) mere submission of quotation does not entitle a bidder for award of contract.

# 16. Award of contract:

- a) The Office of the Director, Animal Husbandry and Veterinary Department shall award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.
- b) Notwithstanding the above, the Director, Animal Husbandry and Veterinary Department also reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- c) The bidder whose quotation is accepted will be notified of the award of contract by the Director, Animal Husbandry and Veterinary Department prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply order.
- 17. **Delivery:** The bidder shall complete delivery of Cow Mats **within four (4) days** from the date of issue of the work Order. The bidder will be solely responsible for delivering the Cow Matsto the mentioned address and this office will not bear any cost associated with the shipment, transport and delivery of theitems.
