

1. Terms and conditions:

1. Tender should bear a court fee stamp of Rs.8.25 (Rupees eight and paise twenty five) only non- refundable to be affixed with the tender without which no tender will be considered for acceptance. Tenders should always be placed in sealed cover with **Group No. & name of the work written in the envelop**, will be received in the office of the Director, Animal Husbandry and Veterinary Department, Assam, Chenikuthi, Guwahati-3 upto 14.00 hrs of 03.07.2020 and will be opened on the same date at 14-30 hrs in presence of the tenderers or their authorized representatives who wish to attend.
2. **The tenderer must furnish the following information/documents along with the tender failing which the tender will be summarily rejected:-**
 - a. Court fee stamp of Rs.8.25 only.
 - b. Requisite EMD in shape of call deposit / DD/TDR pledged in favour of the Director, Animal Husbandry and Veterinary Department Chenikuthi, Guwahati-3.
 - c. Copy of up-to date departmental contractor registration certificate.
 - d. GST registration certificate.
 - e. Work done certificate during last three years.(2017-18,2018-19 & 2019-20)
 - f. EPF for Class I(C), Class I(B) and Class I(A).
 - g. Up to date labour lisenec.
 - h. Up to date electrical contractor lisenec/undertaking from license holder with NOTARY.
 - i. Bank solvency certificate.
3. The tender without Earnest Money will be summarily rejected. In case of SC/ST/OBC tenderer, the Earnest Money will be 1% of the work value **and the earnest money should be deposited in the form of DD/STDR/TDR/CD pledged in favour of Director , Animal Husbandry & Veterinary Department, Assam, Chenikuthi, Guwahati-3.**
4. The Earnest Money of the unsuccessful tenderer will be released within one month from the date of award of contract to the successful tenderer.
5. The time allowed for completion is as per NIT, starting from the 7th day of issue of formal work order.
6. The tenderer shall quote the rates on flat percentage basis **at per/above/below** the APWD Schedule of rates for Building,water supply & sanitary and electrical for the year 2013-14 and departmental approved analysis rate for non-schedule item of works if any

9. The successful tenderer have to sign the contract agreement in APWD F-2 Form. The 2% Earnest Money deposited by the tenderer will be converted as Security Money and remaining 8% Security Money will be deducted from bill.

11. The acceptance of tender will rest with the **Director , Animal Husbandry & Veterinary Department, Assam, Chenikuthi, Guwahati-3**, who does not bind himself to accept the lowest tender and reserves to himself the authority to reject any or all tenders received without assigning any reasons thereof.
12. All tenders in which any of the prescribed conditions are not fulfilled or are incomplete in any respect are liable to be rejected.
13. Canvassing in connection with tender is strictly prohibited and the tenders submitted by the conditions that resort to such canvassing would be liable to rejected
14. On acceptance of tender, the name of the accredited representative(s) of the contractor who should be responsible for taking instruction from the Engineer-in Charge shall be communicated to the Engineer-in Charge.
15. Special care should be taken to write the rate in figures as well as in words in such a way that interpolation is not possible.

16. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering department of the State /Central Govt. is allowed to work as a contractor for a period of two years after his retirement from Govt. service without the prior permission from the Govt. This contract is liable to be cancelled if either the contractor or any of employees is found at any time to be such a portion that had not obtained the permission of the Govt. as aforesaid before submission of tender of engagement in contractor service.
17. The tender for works shall remain open for acceptance for a period of 180 days from the date of opening the tenders. If any tenderer withdraws his tender before the said period or makes any modification in the items and conditions of the tender which are not acceptable to the department, then the Govt. shall without prejudice to any other right or remedy or be at liberty to forfeit an amount equivalent to 2% of the value of the contract either from the registration fees of the contractor or any other
18. A contractor or contractors who himself/themselves has/have tendered or who may tender for the same work shall not witness the tender for the work. Failure to observe this condition should render tenders of the contractors tendering as well as witnessing the tender liable to summary rejection.

20. Before tendering, the intending tenderer shall inspect the site to fully acquaint himself about the condition in regard to accessibility of site and locality, nature and extent of ground working conditions affecting accommodation and movement of labour etc required for the satisfactory execution of the work/contract. No claim whatsoever on such account shall be entertained by the department under any circumstances.
21. The intending tenderer should also inspect the site and satisfy himself about the quality and availability of various materials. The department shall not consider, after acceptance of the tender/contract, to any extra charges for lead of any other reasons, in case, the contractor is found later on to have misjudged quality and availability of materials in the quarry.
22. The Contractor's responsibility for the contracts shall commence from the date of issue orders of acceptance of tender.
23. **Unsealed tenders shall be summarily rejected.**
24. **The contractor should read the specifications and study the other terms and conditions carefully before submitting the tender.**
25. **If it is found that the tender is not submitted in the proper manner or conditions, too many corrections or assured rates or amount, it would be open for the department to take suitable action against the contractor.**
26. **The tenderer shall sign a declaration under the official secret act maintaining secrecy of the tender documents drawing or any other records connected with the work given to them. The unsuccessful tenderers shall return all the drawing given to him.**
