With a view to provide the delivery of public service to the eligible citizen of Assam within stipulated time limit and for matters connected therewith, the Governor of Assam is pleased to notify the following service to be provided by AH & Vety. Department, Govt. of Assam

- 1. Name of Service: Post Mortem Report
- 2. Eligibility Criteria: All Citizen of Assam.
- 3. Step by step procedure: Application in the prescribed format may be (pertaining to time line) submitted by a person for post mortem report before the Designated Public Servant (nearest veterinary surgeon). Documents as sought in the standard application format may be provided by the applicant. The Designated Public Servant may seek more information relevant to the subject if felt necessary. The Designated Public Servant i.e. the nearest designated veterinary surgeon will perform the post mortem and give the report within a maximum period of 3 (three) days. Provided that, in case, the death is due to any disease and Designated Veterinary Surgeon feels that any sample (morbid or sera) is required to be sent to laboratory for testing, the Designated Veterinary Surgeon will inform the applicant about the same and the report will be submitted within 3 (three) days of receipt of the same from laboratory.

With a view to provide the delivery of public service to the eligible citizen of Assam within stipulated time limit and for matters connected therewith, the Governor of Assam is pleased to notify the following service to be provided by AH & Vety. Department, Govt. of Assam

- 1. Name of Service : Valuation Report
- 2. Eligibility Criteria: All Citizen of Assam.
- 3. **Step by step procedure**: Application in the prescribed format may be (pertaining to time line) submitted by a person for Valuation Certificate before the Designated Public Servant (nearest veterinary surgeon). The Designated Public Servant may direct the applicant to keep the animal with him for a maximum period of 10 (ten) days for surveillance and then give the certificate. The Designated Veterinary. Surgeon may, with the prior permission of the District Veterinary Officer keep the animal for an additional period of 3 (three) days by specifically citing the reason for requirement of such extension of time, but in any case, must furnish the certificate within 15 (fifteen) days. The food for the animal during the period of surveillance shall be supplied by the owner of the animal
